

# PRIVACY POLICY

Your privacy is very important to us. Accordingly, we have developed this policy in order to help you understand how we collect, use, communicate, disclose and make use of personal information. The following outlines our privacy policy.

- We will collect and use personal information for the purposes stated in the Information Use section below;
- We will use personal information solely for those purposes and for other compatible purposes, or as required by law;
- We will only retain personal information as long as necessary to fulfill those purposes;
- We require our vendors and agents to use safeguards that protect information at least at the same level as our own safeguards;
- We are committed to conducting our business in accordance with these principles in order to ensure that the confidentiality of personal information is protected and maintained.
- If you do not agree with the principles states in this Privacy Policy then do not use or purchase products on our Site;

## MAKING A PURCHASE

In order to complete a purchase on [cgmcncare.com](http://cgmcncare.com), it is necessary to provide a billing address, phone number, shipping address, and payment information. By making a purchase, you become a registered user of [cgmcncare.com](http://cgmcncare.com). You can store information needed to make a future purchase, such as your credit card number, shipping and billing addresses in the [Manage My Account](#) page.

## INFORMATION USE

We use your personal information to serve you and meet your needs to our best ability. For example, when you use our website, cookies help to recognize you and your preferences. We use your product purchase and registration information to process your purchases, manage subscriptions, send messages and provide product support and to keep you informed about new products and features we offer to our customers. We also use your information for research into improving our products and services, for planning new features and updates and to customize and improve our websites. For the safety of our customers and employees, we may use information we collect to detect and prevent potential or actual claims and prohibited behaviors, such as fraud or attempts to breach our information security.

## CHILDREN UNDER 13

We comply with the Children's Online Privacy Protection Act of 1998. If you are under the age of 13, you can look at our Sites, but you cannot make a purchase. You also cannot become a registered user or use any service on our Sites that asks for personal information. Our Sites are not designed for children. We do not wish to collect personal information from children under 13. This policy is designed to protect children. Federal law requires us to take special steps to

safeguard children's privacy.. If you are under 13 and want to make a purchase, please ask a parent or legal guardian to place the order for you.

### **SOCIAL COMMERCE AND OTHER THIRD PARTIES**

We work with trusted third parties, including social network sites like Facebook and Twitter, and with application developers, who specialize in social commerce, so we can connect to your social networks. All of these companies operate Third Party Sites. We provide access to our Sites to third parties and business partners so we can generate interest in our products among members of your social networks and to allow you to share product interests with friends in your network.

Your use of any features on our Sites that are provided by a third party may result in information being collected or shared about you by us or by the third party. Information collected or shared through any such third party features is considered "public information" by us because the Third Party Sites made it publicly available. If you do not want us to be able to access information about you from Third Party Sites, you must instruct Third Party Sites not to share the information. We cannot control how your data is collected, stored, used or shared by Third Party Sites or to whom it is disclosed. Please be sure to review the privacy policies and privacy settings on your social networking sites to make sure you understand the information they are sharing. If you do not want a Third Party Site to share information about you, you must contact that site and determine whether it gives you the opportunity to opt out of sharing such information. Common Ground MenCare is not responsible for how these third parties may use information collected from or about you. However, we do identify any areas on our Sites where third parties share information about you.

### **TRACKING ANONYMOUS SITE BEHAVIOR**

We use technology that tracks anonymous (non personally-identifiable) traffic data on cgmenicare.com. This technology uses 1st party (cgmenicare.com) "cookies" that collect anonymous information about how the site is used by our customers. We do this in order to improve both the experience on Cgmenicare.com and how we serve our customers in general. These cookies do NOT collect, store, or transmit any personally -identifying information. We also use Display Advertising and Remarketing through Google Analytics on our website.

Google and other third-party vendors show our ads on sites across the internet based on first-party and third -party cookies.
